



### Methodology



- 600 telephone interviews with likely November 2016 voters via landline and cell phones
- Conducted December 9 14, 2015
- Margin of sampling error +/-4.0% at the 95% confidence interval
- Due to rounding, some percentages do not add up to 100
- Selected comparisons to June
  2008 survey

### **Survey Approach**



- Half of respondents heard a potential general-purpose sales tax throughout the survey, with custom messages
- The other half heard a utility users tax modernization measure
- The margin of error for each half-sample is +/-5.7%
- All respondents heard one question about a potential parks bond measure

### **Key Findings**

- The drought and cost of housing are voters' top concerns. Since last surveyed in 2008, Alameda voters have become less worried about the economy and crime, and more worried about housing costs and traffic.
- Voters are largely satisfied with City services, with the exception of street maintenance.
- A general-purpose sales tax measure begins with support safely above the majority-vote threshold (63% "yes").
- A UUT modernization measure starts with 52% "yes" and a significant share undecided (23%); an informational statement about UUT measure brings support to 68%.
- An exchange of pro/con arguments ends with the measures earning aboutequal shares of the "yes" vote – 61% for a sales tax and 64% for UUT modernization.
- A parcel tax measure funding parks falls short of the two-thirds threshold 49% "yes" and 41% "no."




## Voter Mood and Community Concerns





# Crime and gangs are seen as much less serious problems than seven years ago.




# Government waste, taxes and the economy have receded as perceived problems.



**City of Alameda Essential City Services Measure.** To maintain Alameda's financial stability and to fund essential City services such as:


- Police response to violent crimes, burglaries, and other safety needs;



## A Potential UUT Modernization Measure



**City of Alameda Utility Users Tax Modernization and Essential City Services Protection Measure.** To maintain financial stability without increasing tax rates and fund City services such as:


- Police protection;

- Pothole/street/storm drain repairs;
- Neighborhood park maintenance; and
- Other City services,

If there were an election today, do you think you would vote "yes" in favor of this measure, or "no" to oppose it?




# Voters heard a short explanation of the UUT modernization measure.

Now let me tell you more about this ballot measure. Alameda's utility users tax was originally passed by voters in 1995 and currently applies to electricity, natural gas and cable television services, and to telephone calls made on landlines and cell phones.

However, newer telecommunication technologies – such as broadband wireless service and voice over IP – are not covered the by the existing utility users tax. Additionally, some telecommunications providers apply the tax and some don't.

This measure would not increase tax rates, but would modernize the City's utility users tax to ensure that all residents are treated equally regardless of what types of telecommunications services they use now, and in the future.


# After a short explanation, support grows to 68%, though it is fairly soft.

### **Positive Messages Test in Survey**

- Help fund park maintenance
- Modernizes the UUT everyone treated the same (UUT only)
- Help fund storm drain improvements
- UUT does not increase tax rates (UUT only)
- Only raises sales tax five pennies on a \$10 purchases (Sales tax only)
- Help fund street maintenance
- City has declining revenue on the existing UUT (UUT only)
- Help maintain Alameda's quality of life
- Help keep Alameda a safe place
- Help City prepare for a disaster
- Subject to fiscal accountability
- Help the City prepare for the next recession

Positive messages were developed with information materials considered.

### **Negative Measures Tested in Survey**

- Isn't needed with City budget surplus
- Recent Alameda sales tax measure rejected (Sales Tax only)
- Pays only for pensions
- Measure is a trick (UUT only)
- Funds won't trickle down to areas that need it, like parks and libraries
- $\circ~$  Can't afford to raise taxes with high housing costs
- City should just cut spending
- Will lead to out-of-control growth

Negative messages were developed with anticipated opposition concepts.



## **Testing a Parks Funding Measure**



#### **Measure Language Tested**

**City of Alameda Park Improvement Measure.** To maintain community and neighborhood parks throughout Alameda by:


- Repairing aging/deteriorating playgrounds, athletic fields and recreation facilities;
- Repairing/providing clean restrooms;
- Improving park pathways/safety lighting;
- Opening and maintaining new parks, like the Jean Sweeney Open Space Park;
- Ensuring parks are well-maintained and available to the entire community, including youth and seniors,

Shall the City of Alameda establish a \$25 per parcel tax, providing about \$500,000 annually, requiring independent audit and public review of spending?

If there were an election today, do you think you would vote "yes" in favor of this measure, or "no" to oppose it?









# **Survey Conclusions**



### **Survey Conclusions**

- Both the utility users tax and sales tax measures appear viable, though a UUT will require more public education.
- While voters are more likely to see the cost of housing and the drought as problems for the City than crime and gangs, they prioritize measure spending to be on public safety items such as emergency preparedness and 911 response times.
- Voters also find arguments about general infrastructure repairs and maintenance, as well as the relative size of the taxes, compelling.
- A parks parcel tax to repair and improve existing parks and to open new parks does not appear viable at this time.

### Sales Tax vs. UUT Ballot Measure

- The Sales Tax measure appears viable (61%) and requires less voter education.
- However, Alameda has reached its statutory cap of 9.5%, and requires State Legislation authorization to increase it.
- Raising this cap in time for a November 2016 election requires a 2/3 vote by the Legislature as an urgency bill. It is highly unlikely to pass in the current political climate.
- Legislation could still be pursued with a simple 50% majority vote, not an urgency bill, and has a longer timeframe. The City could then consider a sales tax for 2018 or 2020 ballot.
- A sales tax measure would raise \$3.5 million for the General Fund.

### **Sales Tax vs. UUT Ballot Measure**

- A Utility Users Tax (UUT) measure also appears viable (64%) but requires significant public education.
- The UUT measure will raise \$1.6 million for the City's General Fund.

#### Recommendation

> Pursue the UUT in November 2016.

Pursue state legislation related to increasing the Transaction and Use Tax to allow the sales tax measure option for future ballots.

  - Report on work done to date, such as stakeholder education, developing informational materials, and community engagement.
  - Review draft resolution of ballot measure language.
  - Discuss next steps.
- 3) Council approval of final ballot measure language June 2016
